STATE OF COMPANY'S AFFAIRS

During FY 2025-26, the Company continued its business activities as a NBFC-ICC in accordance with its Memorandum and Articles of Association and applicable regulatory framework.

During the financial year under review, the Company witnessed a significant improvement in its financial performance, with an increase in profit as compared to the previous financial year. The improved profitability reflects the Company's continued focus on operational efficiency, prudent cost management and strengthening of its business operations. This positive

performance demonstrates the Company's commitment towards sustainable growth and further strengthening its financial position.

The Board of Directors remains optimistic about the Company's future prospects and is committed to pursuing a growth-oriented strategy focused on innovation, operational excellence and responsible business practices. Supported by a robust governance framework and a disciplined approach to business, the Company aims to maintain consistent performance and create sustainable value for its stakeholders in the years ahead.

CHANGE IN NATURE OF BUSINESS

The Company's principal objects are to undertake leasing, hire-purchase, lending and financing activities, provide loans against property/securities, finance industrial and trading enterprises, and raise funds through borrowings and securities, without carrying on banking business. The Company also undertakes to carry on investment and treasury activities, including acquisition, holding, purchase, sale and dealing in shares, stocks, securities, debentures, bonds and other financial instruments. During the financial year under review, there were no changes in nature of business of the Company.

SHARE CAPITAL STRUCTURE

The authorized share capital of the company is Rs. 5,00,00,000/- (Rupees Five Crores only) and paid-up Equity Share Capital as on 31st March 2026 was Rs. 4,99,80,000/- (Rupees Four Crores Ninety Nine Lakhs Eighty Thousand only), each share having face value of Re 1/- (Rupee One only). There was no changes in the capital structure of Company and Company has not issued new shares or convertible securities during the year 2025-2026. The Company not issued shares with differential voting rights or granted any stock options or sweat equity shares. Further the Company has not issued any debentures, bonds, warrants or any non-convertible securities during the year 2025-2026.

VIGIL MECHANISM/WHISTLE BLOWER POLICY

In order to ensure that the activities of the Company and its employees are conducted in a fair and transparent manner by adoption of highest standards of professionalism, honesty, integrity and ethical behavior the company has adopted a vigil mechanism policy.

The Company has established a Vigil Mechanism/Whistle-Blower mechanism in accordance with applicable provisions of the Companies Act, 2013 and SEBI LODR Regulations.

The mechanism provides an avenue to Directors and employees to report genuine concerns regarding unethical behavior, actual or suspected fraud, violation of the Company's policies or other concerns.

The mechanism provides adequate safeguards against victimization of persons using the mechanism and provides direct access to the Chairperson of the Audit Committee in appropriate cases.

PREVENTION OF INSIDER TRADING

There was qualification remark given by Statutory Auditor in the auditor report.

Qualification: The Company has used accounting software for maintaining its books of accounts for the financial year ended on 31st March 2026 which does not have a feature of recording audit trails (edit log) facility and the same has been operated throughout the year for all relevant transaction recorded in the software.

Management Reply: The Company is in the process of updating its accounting software to include the ability to record audit trails and alter logs. The company has accelerated the process of updating its accounting software, and soon it will be used to maintain its books of accounts audit trails (edit log) feature.

We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatement in the Standalone Financial Statements.
- D. We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
- E. We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.
- F. - i) The Company does not have any pending litigations which would impact its financial position.
 - ii) The Company did not have any long-term contracts including derivative contracts for which there were any material foreseeable losses.
 - iii) There were no amounts which were required to be transferred to the Investor Education and Protection Fund by the Company.
 - iv)

Note:1 SIGNIFICANT ACCOUNTING POLICIES

1. BASIS OF PREPARATION OF FIANANCIAL STATMENTS

Provision for Current Income Tax is made on the current tax rate based on the assessable income computed under the Income Tax Act, 1961.

Deferred Tax Assets and Liabilities are recognized for future tax consequences attributable to the timing differences between taxable income and accounting income that are capable of reversal in one or more subsequent periods and are measured using tax rates enacted as the Balance Sheet date.
